Abstract *This research aims to determine the forms of violence and the factors that cause them as well as concrete actions taken by the P2TP2A Institution in resolving existing cases by analyzing them using Islamic Law. 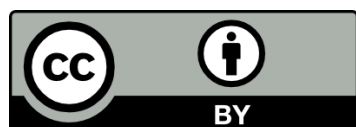
