ABSTRACT

In determining location of the caning, Islamic law requires fulfilment of two principles namely "open space" and "visible" to the public. However, the law that guides implementation of sharia in Aceh does not regulate details where the caning should be executed. Although the Governmor has issued a Governor Regulation (Pergub; Peraturan Gubernur) Number 5 of 2018 concern-ing the Enactment of the Sharia Jinayat Law to complete what is missed from Qanun Number 7 of 2013, including the spot for execution, the location re-mains vary. Hence, the issues that need to be scrutinized in this study are about shifting norm from "open space" to "prison space" and causes beyond
