- It seems that the paper takes an anthropological approach, however, the paper lacks of describing the whole cultural system of Acehnese society that influences women in the post-conflict Aceh era. Please revise!
- There are many syntax errors and mistakes to be revised in order to be a good academic research paper in English language. Please revise!

Reviewer B:

The analysis is less sharp and poor examples. The author has been too at length to describe the literature related to women in Aceh but has forgotten to provide the authorial voice. In the case of this article, the condition of women in post conflict Aceh has not been thoroughly analyzed. The citation style has not followed the style of the mazahib journal environment. English also needs improvement.
