Title

the title can be made more specific - Who is homo Islamicus: A Quranic perspective of Economic agents in Islamic economics.

#### Abstract:

1. Under Purpose, "This paper aims to explain the nature of economic agent in Islamic economics (homo Islamicus)." There are already a lot of literature "explaining the nature of ... homo Islamicus" since the start of Islamic revivalism (e.g. writings by Mawdudi and other pioneers of IE), and in recent years we also have a number of textbooks in Islamic economics discussing the same; hence the purpose of this potentially a 'journal article' must be more specific

and able to fill the existing gap in the body of knowledge in the area.

- 2. Under Design/methodology/approach The description of the methodology used for the study in the abstract is not in line with the description of the author in the main text of the article, i.e. "A theory of ethics that would properly capture all-dimensions of human-self, his nature, well-being, and his relationship with other beings will be developed based on the Qur'anic teachings."
- 3. Under Findings- Please include a brief summary of the findings; at the moment it is too general.
- 4. The write-up on Research limitations/implications is not appropriate; please revise.
- 5. Under Practical implications- The discussion in the paper is entirely normative based; the author should explain how this normative behavioural framework of homo Islamicus "... will portray all concepts in actual realities."
- 6. Under Originality- The author suggests that the paper "promotes a conception of economic agent in Islamic perspective (termed as homo islamicus)"- the concept of homo Islamicus has been used as a representation of an economic agent in theorizing Islamic economics for many decades now, and therefore claiming to "promote" this concept is not appropriate.

#### Introduction:

- 1. The opening of the article should be revised to reflect the focus of the article, i.e. economics. The article should start with the notion of economics as part of the discourse in moral philosophy; then the discussion can elaborate further about the philosophy of ethics/moral philosophy, etc.
- 2. "However, as Pojman (2006: ix) notes that ethics "is often being constructed to serve human needs and desires" rather than to be the guidance of how human being should be as we will note in this article."

The above statement is not clear; what the author is trying to argue? Needs clarification.

- 3. Please include a short gap analysis in the introduction section; Are the current literature on homo Islamicus in Islamic economics lack in this specific area given that the concept of homo Islamicus has been used to represent economic agents in Islamic economics for many decades now?? The gap analysis can help the readers of this journal on how this paper contributes to the current body of knowledge.
- 4. The author should include/acknowledge past literature in Islamic economics that have introduced the term homo Islamicus in Islamic economics literature.
- 5. At the end of the introduction section, please also give a brief structure of the paper and how they assist the paper in achieving the stated objective.

#### The Self of Homo Islamicus

1. "However, unlike homo Economicus, homo Islamicus is having clear objectives in all his actions, namely "to maximize moral energy, to control and harness his desire, make it obedient to his intellect and thus arrive at spiritual freedom" (Mutahhari, 1983: 33)."

The concept of homo economicus is introduced here without sufficient context and description. Perhaps a critique of homo economicus can be inserted in the Introduction section as part of the justification for the need of having homo Islamicus as the microfoundation of Islamic economics to provide the context for the above statement.

2. "This is possible by introducing moral values as part of preference functions, internalizing moral norms or rules as motives as well as constraints in actions, and incorporating those values and moral positions in policy prescriptions (Furgani, 2017)."

The above policy/practical implications (along with other potential implications) should be highlighted in the conclusion section.

### Homo Islamicus' Wellbeing

1. To be consistent with other sections, and to be in line with the title of the paper--'Qur'anic perspective', this section should start with reference to Qur'anic verses before citing the opinion of scholars.

#### Conclusion

1. The author should conclude the paper by identifying/listing a number of theoretical propositions (testable propositions) relevant to the behavioural framework expected of homo Islamicus based on the findings. This would represent a worthy contribution to the literature on homo Islamicus (without this, the paper lacks substantive contribution to the current literature on homo Islamicus). This is also expected by the readers since the last para before the Conclusion mentions "The above characteristics and guidelines of homo Islamicus as derived from the Qur'an as the primary sources of knowledge in Islamic epistemology will be the guidelines in developing the assumptions and hypothesis of analysis."


