Abstrak dan pendahuluan juga tidak ada indikasi apakah penulis akan membahas tentang hukum Islam atau hukum keluarga yang menjadi fokus utama Jurnal Samarah. Hal. 8, symptom dan indikasi radikal pada "mahasiswi bercadar" penting dihadirkan di awal bagian ini untuk menghindari sub judul yang mendukung sudut pandang orientalist. Narasi kasus hal. 9 diubah ke bagian awal "fenomena mahasiswa bercadar".

Paragraf yang berisi pertanyaan-pertanyaan di hal.9-10 membingungkan. Dimana penulis akan menjawab pertanyaan tersebut?

Hal. 10, "Ancaman di Jalan Pergi-Pulang antara Kampus dan Rumah" apa korelasi subjudul ini dengan subjudul sebelumnya?
